

DMCII LICENSE AGREEMENT FOR DATA OR PRODUCTS PROVIDED

NOTWITHSTANDING ANY CLAUSE TO THE CONTRARY IN THE DMCII LICENSE AGREEMENT BELOW, ALL END-USERS HAVE THE RIGHT TO CREATE AND FREELY DISTRIBUTE OR SELL ANY VALUE-ADDED PRODUCTS AS IT WISHES. VALUE-ADDED PRODUCTS ARE DEFINED AS ANY THEMATIC, CLASSIFIED OR VALUE-ADDED PRODUCTS FROM WHICH THE SENSOR DN, RADIANCE OR REFLECTANCE VALUES CANNOT BE RETRIEVED.

This is a legally binding agreement between the end user, and DMC International Imaging Limited ("DMCii"). DMCii has the right to license worldwide remotely sensed DMC Data acquired by DMC satellites and DMCii derivative Products. The DMC satellites are owned and operated by various national bodies, which have authorised DMCii to distribute their Data or Products.

1. LICENSE.

This DMCii License Agreement for Data or Products ("License" or "Agreement") permits you to use the DMCii Data or Products acquired under the terms of this License ("DMCii Data or Products ") on computer systems owned or leased by the licensed entity provided that such Data or Products may not be accessed by users outside of the licensed entity except as specified in article 2 below. The licensed entities are those, which DMCii has licensed. The Licence types are as follows:

A. Organizational license includes all the users of the licensed business enterprise located within the country for which the Licence is granted.

B. Government license includes all the Departments of and Agencies within the licensed Government excluding Colleges and Universities.

C. Local Government, and Academic license includes all the Departments of and Agencies within the licensed County and Local Government Authorities and schools, Colleges and Universities within the licensed area.

2. COPYRIGHT, USES and RESTRICTIONS.

The DMCii Data and Products are owned by DMC International Imaging Limited or its suppliers and are protected by United Kingdom copyright laws and international treaty provisions. Therefore, you must treat the DMCii Data or Products like any other copyrighted material except that you may make copies of and/or provide access to the DMCii Data or Products solely for the purpose of facilitating use by the licensed entity(s). You may copy the written materials accompanying the DMCii Data or Products for use by the licensed entity(s).

You may analyse, process, and display the licensed DMCii Data or Products and may make such DMCii Data or Products and the results of such analysis or processing available to employees of your organization. You may make an unlimited number of film, print and Internet Display copies of the DMCii Data or Products for use outside your organization, provided that: (1) all copies include a copyright notice prominently displayed in or adjacent to the DMCii Data or Products; (2) you may not sell any copies made for such purposes; and (3) you prohibit this material from being downloaded or screen captured by individuals or organizations located outside of the licensed entity.

Optional extended use licenses which have been properly acquired from DMCii include the following:

A. Internet JPEG GIF Download license permits display of the DMCii Data or Products on the Internet in a format, which can be downloaded and screen captured. Downloads or screen captures of DMCii Data or Products posted on the Internet must be non-georeferenced and in either JPEG or GIF format.

B. Internet Georeferenced Download license permits display of the DMCii Data or Products on the Internet in a format which can be downloaded and screen captured in any georeferenced or non-georeferenced format.

You may prepare value added products based upon the licensed DMCii Data or Products and publish, sell or distribute such materials, but only if such materials do not reproduce in any way the licensed DMCii Data or Products.

You may make the licensed DMCii Data or Products available to contractors and consultants, but only for use on behalf of your organization, and only if each such person agrees in writing (a) to be bound by the same limitations on use as apply to you; and (b) to return to you all DMCii Data or Products upon completion of the contracting or consulting engagement.

You may not rent or lease the DMCii Data or Products, but you may transfer your rights under this Agreement on a permanent basis provided you transfer this Agreement, the DMCii Data or Products, and all accompanying written materials and retain no copies, and the recipient agrees to the terms of this Agreement. The transfer of possession terminates your license from DMCii.

When reproducing DMC imagery in print or internet display for any of the purposes stated in this Agreement the logo of DMCii should be displayed and you shall include one of the following notices as appropriate for the relevant satellite:

File names commencing U2: "UK-DMC-2 image copyright (c) 'year' DMCii"

File names commencing DE: "Deimos-1 image copyright (c) 'year' Deimos Imaging"

File names commencing NX: "NigeriaSat-X image copyright (c) 'year' NASRDA"

The logo of DMCii will be supplied by DMCii as an electronic file on request.

3. LIMITED WARRANTY.

DMCii will use its best efforts to ensure that any DMCii Data or Products provided to you conforms to the DMCii Data or Products requested and that the medium in which the DMCii Data or Products is delivered is free of physical defect. If any Data or Products does not meet the foregoing standards, your sole and exclusive remedy will be to return such DMCii Data or Products to DMCii within thirty (30) days of your receipt thereof. If you return the DMCii Data or Products within such period and if DMCii reasonably determines that such Data or Products, at the time they were delivered to you, failed to meet such standards, DMCii will, at its discretion, either (a) retain the DMCii Data or Products and refund the applicable license fee paid with respect to it, or (b) replace or repair the DMCii Data or Products and return it to you.

4. WARRANTIES.

Except as provided in the preceding paragraph, any DMCii Data or Products licensed pursuant to this agreement are provided without warranty of any kind, whether express or implied, including implied warranties of merchantability and fitness for a particular purpose, even if DMCii is advised of such purpose. DMCii's liability with respect to any such Data or Products will, in any case, be limited to a refund of the license fee paid for such Data or Products. In no event will DMCii be liable to you for any special or consequential damages, including lost profits resulting from any defect in any DMCii Data or Products or any delay in delivery.

5. OTHER.

This Agreement shall be governed by the laws of the United Kingdom. DMCii retains all rights not expressly granted. This license is effective until terminated. It may be terminated by you by destroying all copies of the DMCii Data or Products. It will terminate

automatically if you fail to comply with any of the terms of this License, and on any such termination you will destroy all copies of the DMCii Data or Products.
